Our policy as Bericap Kapak San. A.Ş.;

As Bericap Kapak San. A.Ş., we establish, implement, and continuously improve quality, environmental, energy, occupational health and safety management systems for the production of lids and handles for packaging, aiming for a sustainable future. This includes the OCS (Operation Clean Sweep – a cleaning and control program designed to prevent plastic granules, flakes, and dust from entering the environment).

In this regard, we commit to the following;

- Within the framework of the quality management system, to ensure the production of products that meet customer requirements and comply with international and local regulations, using modern methods and techniques,
- Adopting 100% food safety as a principle, ensuring the emergence of final products with a continuous improvement mindset by completely eliminating physical, chemical, and microbiological hazards,
- Ensuring product quality during production, not after production is complete, investigating the reasons why product quality does not meet specifications, and completing the work necessary to eliminate these reasons,
- Strengthening the sustainability of the business by making cultural, technological, financial, managerial, and knowledge investments for its present and future, and considering environmental, energy, occupational health, and safety factors when making decisions in investment, design, and procurement processes.
- Systematically identifying and evaluating the environmental aspects that may arise from our products, services, and
 activities from a life cycle perspective, controlling environmental impacts, protecting the environment, including
 preventing plastic (granule, flake, powder) loss,
- Complying with relevant legal regulations and international management system standards regarding quality, environmental, energy, occupational health, and safety; determining other conditions that must be met by evaluating the needs and expectations of relevant parties; and ensuring compliance with these conditions.
- Aiming to minimize all material, raw material, and energy usage, targeting the use of reusable and recyclable resources as much as possible,
- Minimizing environmental impacts, increasing social benefits, and adhering to transparent, ethical governance principles,
- Researching the reuse and recycling possibilities of solid, plastic (granules, flakes, powder), liquid, and gas waste, minimizing waste wherever possible and throughout the entire facility, and aiming for waste-free processes,
- Ensuring the development of our suppliers and subcontractors by selecting and evaluating their performance in line with our management systems,
- Ensuring safe and healthy working conditions to prevent injuries and health impairments,
- Eliminating occupational health and safety hazards, and where this is not possible, taking the necessary measures to reduce occupational health and safety risks,
- Ensuring employee participation and soliciting their opinions regarding the implementation of management systems and legal regulations,
- Continuously improving performance in quality, environment, energy, occupational health and safety, quality culture, and product safety,
- Setting quality, environment, energy, and occupational health and safety targets, planning activities to achieve these targets, and providing the necessary information and resources,
